- 1. To government authorities (eg immigration, border control, public safety and security entities and the fight against terrorism).
- 2. Within the scope of merger, acquisition and/or incorporation processes in which it is found, when such transfer is necessary within the legitimate interests of MA TRAVEL LTD BRANCH IN PORTUGAL or third parties to whom the data is communicated. #### MINOR'S DATA:

#### PERIOD OF RETENTION OF PERSONAL DATA:

Customer's personal data is kept by MA TRAVEL LTD – BRANCH IN PORTUGAL for the period strictly necessary to meet the purposes, except when there are conservation obligations imposed by the applicable legislation, or legitimate interest, which impose the maintenance of your personal data for a longer period.

Personal data collected for the purpose of sending communications about campaigns and promotions will be kept for a period of 2 years.

## PERSONAL DATA SECURITY MEASURES:

MA TRAVEL LTD – BRANCH IN PORTUGAL uses adequate security measures to protect your data, including adequate technical and organizational measures to protect them against abusive or illegal treatment and against their accidental loss, damage or destruction.
